## Responsibilities of Gupta Dental Clinic Anuppur

- Assign qualified mentors to guide and supervise the interns during their training period.
- Assess the performance of interns and provide constructive feedback.
- Maintain a safe and conducive environment for learning and training.
- Consider qualified interns for potential placement, subject to the availability of positions and their performance during the internship.

**Duration:** This MoU will be valid for an initial term of [<sup>05</sup>years], starting from the effective date of signing. After the initial term, it may be renewed or amended by mutual agreement in writing.

**Confidentiality:** Both parties agree to treat any confidential information shared during the course of this collaboration with utmost confidentiality and not disclose it to any third party without prior written consent from the disclosing party.

**Termination:** Either party may terminate this MoU by providing a prior written notice of [30 days] to the other party. The termination will not affect the rights and obligations accrued before the termination date.

**Governing Law:** This MoU shall be governed by and construed in accordance with the laws of India.
